THE AMAMI GROUND THRUSH DISTINCT FROM THE WHITE'S GROUND THRUSH

An important endemic resident found only in Amami-oshima as it is, the Amami ground thrush (the Amami tiger thrush, or O-toratsugumi in Japanese) had been regarded by many authors as a subspecies of the White's ground thrush of a wide distribution. It seems very few in number. For these reasons, this conspicuous resident was entirely overlooked in such recent publications as Massey et al. 1982: Field Guide to the Birds of Japan, Takano, 1982: the same as above in Japanese, and Yamashina, 1986: World List of Birds. First of all, the scientific names of it appeared on references in the main shall be shown below.

1982 *Turdus dauma*: Takano, The same as above in Japanese (Nippon-no-Yacho), 247 (Toratsugumi in part).

1986 Zoothera dauma: Yamashina, A World List of Birds (Sekai-Chorui-Wamei-Jiten), 503 (White's thrush in part).

Compared with the White's ground thrush, the Amami ground thrush is apparently larger. The tail feathers of the former are usually 14 in number, while those of the latter are decidedly 12 in number. The voice is a gloomy and monotonous whistle mostly at night in the former, while it is entirely different in the latter and is a fine and cheerful song early in the morning.

Judging from the above-mentioned remarkable characters, Kiyosu (1978, loc. cit.) insisted that the Amami ground thrush is a distinct species from the White's ground thrush, and as the scientific names he gave *Turdus dauma amami* Hartert to the Amami ground thrush and *Turdus aureus aureus* Holandre to the White's ground thrush.

Although I agree with his opinion, I believe that the Amami ground thrush is not a subspecies but a species endemic to Amami-oshima, Japan, and therefore the scientific name of it is *Turdus amami* Hertert. When the narrow divided genus is used, it is *Zoothera amami* (Hartert) (comb. nov.).

By the way, it was reported recently, that the habitats of this species are restricted within the central district of Amami-Oshima (Higuchi, Y. et S. Hanawa, 1985, Habitats of the Amami ground thrush in Amami-oshima (in Japanese). Reserches concerning the peculiar wild birds of Japan, 35-51) and then an establishment for a sanctuary of wild birds in Kinsakubaru is confidently expected.

オオトラツグミは奄美大島特産の独立種

オオトラツグミは奄美大島のみに生息する重要な日本特産の鳥でありながら、最近刊行された 高野、1982 フィールドガイド日本の野鳥、山階、1986 世界鳥類和名辞典などに全く脱落して いる。その理由は、オオトラツグミが広く分布するトラツグミと同種で、亜種の違いとして扱わ れてきたことと、その個体数がたいへん少ないために、結果的には看過されることになったと思 われる。

私は形態ならびに鳴き声などの顕著な特徴から、オオトラッグミは独立種と信じ、学名も Turdus amami Hartert と改めるよう提唱した。分割された風名を採り、Zoothera amami (Hartert) でもよいが、属の包含する範囲はかなり主観的な場合もあるから、使いなれた愛着のある Turdus を生かし、Zoothera は亜属名としてはいかがとも思う。日本野鳥の会の花輪伸一氏のご厚意で、重要な文献を見ることができた。心から謝意を表してペンをおく。
